2nd Largest School District in Pima County Selects the e-IEP PRO

Sunnyside Unified School District (SUSD) has selected the automated e-IEP PRO solution to manage their special needs program. SUSD is switching from its Student Information System special education solution to the e-IEP PRO. At SUSD, the e-IEP PRO will be deployed to manage all of the district's special education documentation, 504 documentation, ELL documentation and state special education reporting and data management needs.

ADE Presents "The Basics of the Special Education Evaluation Process" Webinar

In November, ADE presented a webinar titled <u>"The Basics of</u> the Special Education Evaluation <u>Process</u>". This webinar reviewed issues related to compliance and the effective writing of Evaluations in Arizona. Some highlights of the general evaluation issues reviewed included:

The required participants for an Evaluation were reviewed and it was clarified that for the role of Special Education Teacher, if the student was SLI (Speech Language Impaired) only, then the SLP (Speech Language Pathologist) can sign for this role.



- The appropriate timelines for evaluation completion were presented. For example, a 30 day extension can be granted to the 60 days if it is in the best interest of the child. The 60 day timeline is from Date of Consent through the Date of Eligibility.
- The requirements for Medical Verifications were discussed. It was specified that Medical Verifications are only needed <u>once</u> unless something changes as it relates to the medical diagnosis for the student. Therefore, Medical Verifications do not always need to be updated every year/3 years.

Additionally, interesting issues specific to Re-Evaluations were reviewed that included:

- It was noted that parent consent is not required per IDEA for a Re-Evaluation because this process reviews existing data and checks rate of progress on IEP goals. If additional data was needed after the Review of Existing Data, then Parent Consent would be necessary to assess the student.
- A Re-Evaluation cannot exceed the 3 year timeline, unless the parent and PEA agree not to evaluate. This requires a PWN and an agreement letter document-

ing why the evaluation will not be completed.

- If a student is making significant improvement/nonimprovement or if a parent, teacher or student requests it, a Re-Evaluation can be completed.
- It is not necessary to complete a Re-Evaluation when a student is graduating and receiving a regular diploma or to discontinue a Related Service.

Creating an Integrated Student Information System with the e-IEP PRO

As part of its interoperable features, the e-IEP PRO can be easily set to utilize secure Internet-based oneway or two-way database-todatabase connections, thereby allowing the e-IEP PRO and the district's Student Information System (SIS) to seamlessly interface and share student information. This unique e-IEP PRO interoperability allows your district to leverage its existing technology infrastructure to create a real-time, single, integrated student information repository of general education and special education student information much like (yet in many ways more robust and



comprehensive than) that offered or promoted by SIS software vendors.

Highlights of the e-IEP PRO's leading -edge student information sharing features include:

- Utilizes the district's current student information technology tools and Internet connections so no additional computer hardware, software, etc. need to be purchased by the district.

A new Section 504 Forms Module was included within the Version 12.0 release of the e-IEP PRO. This new module contains a comprehensive set of data-driven, fully integrated forms designed to meet the Section 504 student's individual educational needs. It is a free module and can be easily activated by the district through the e-IEP PRO's system configuration settings.

The 504 Forms Module also includes a set of editable/updatable PDF forms that complement the datadriven forms ensuring that a full and complete set of 504 forms are provided within the e-IEP PRO.

When using this new module, the

district can setup users as 504-only users who will only be able to access the Section 504 Forms Module options and will have limited access to only the 504 students data stored within the e-IEP PRO. Therefore, the e-IEP PRO can be configured to be its own Section 504 system or the 504 Forms Module can be utilized as a fully integrated module within the e-IEP PRO.
